## **The Terror Timeline**

Paul Thompson's *The Terror Timeline* offers a complete and thorough history of the many roads that converged on 9/11, including the development of Islamic fundamentalism, the activities of bin Laden and al-Qaeda, and the failures of U.S. investigations and counterterrorism efforts. It traces the actions (and inactions) of every important figure in the war on terror, both before and after 9/11, bringing them together in a volume that offers a comprehensive and provocative look at this complex subject. ## **The Hidden History of 9/11**

On the morning of September 11, 2001, 19 terrorists hijacked four commercial aircraft and crashed two of them into the North and South Towers of the World Trade Center complex in New York City. A third plane crashed into the Pentagon in Arlington, Virginia. After learning about the other attacks, passengers on the fourth hijacked plane, Flight 93, fought back, and the plane was crashed into an empty field in western Pennsylvania about 20 minutes by air from Washington, D.C. The Twin Towers ultimately collapsed, due to the damage from the impacts and subsequent fires. Nearly 3,000 people were killed from 93 different countries. It was the worst attack on American soil since the Japanese attacked Pearl Harbor in 1941. A detailed account of these events—plus the history that led up to them, and America's response—can be found in *9/11: The Attacks on the World Trade Center and the Pentagon*.

## **9/11: The Attacks on the World Trade Center and the Pentagon**

For over thirty years, World War II veteran and author Burt Hall assessed accountability in government and national security. Now, this seasoned, professional analyst delivers a tough account of what went wrong in our politics and system of government over the past two decades and what we can do about it. The right wing (not to be confused with Conservatism) has hijacked the Republican Party and wrecked havoc

on our nation. It exploited basic flaws in our system to gain power and a series of major setbacks and a weakened democracy have followed. The Right-Wing Threat to Democracy lays out clearly what the basic flaws in our system are and how they can be fixed. The danger is that an ongoing shift of political power to the very wealthy and suppression of voting rights is silencing the voice of the average citizen. If elected officials do not fix the basic flaws, the American people have alternatives in our democracy and must take matters into their own hands.

## **The Right-Wing Threat to Democracy**

George W. Bush has been branded the worst president in history and forced to endure accusations that he abused his power while presiding over a "lawless" administration. Stephen Knott, however, contends that Bush has been treated unfairly, especially by presidential historians and the media. He argues that from the beginning scholars abandoned any pretense at objectivity in their critiques and seemed unwilling to place Bush's actions into a broader historical context. In this provocative book, Knott offers a measured critique of the professoriate for its misuse of scholarship for partisan political purposes, a defense of the Hamiltonian perspective on the extent and use of executive power, and a rehabilitation of Bush's reputation from a national security viewpoint. He argues that Bush's conduct as chief executive was rooted in a tradition extending as far back as George Washington—not an "imperial presidency" but rather an activist one that energetically executed its constitutional prerogatives. Given that one of the main indictments of Bush focuses on his alleged abuse of presidential war power, Knott takes on academic critics like Sean Wilentz and Arthur Schlesinger Jr. and journalists like Charlie Savage to argue instead that Bush conducted the War on Terror in a manner faithful to the Framers' intent—that in situations involving national security he rightly assumed powers that neither Congress nor the courts can properly restrain. Knott further challenges Bush's detractors for having applied a relatively recent, revisionist understanding of the Constitution in arguing that Bush's actions were out of bounds. Ultimately, Knott makes a worthy case that, while Bush was not necessarily a great president, his national security policies were in keeping with the practices of America's most revered presidents and, for that reason alone, he deserves a second look by those who have condemned him to the ash heap of history. All readers interested in the presidency and in American history will find *Rush to Judgment* a deftly argued, perhaps deeply unsettling, yet balanced account of the Bush presidency—and a clarion call for a reexamination of how scholars determine presidential greatness and failure.

## **Rush to Judgment**

## **Real Enemies**

It is Farrell at his best—uncovering the massive financial fraud, special operations and hidden technology of the breakaway civilization.

## **9th of November**

The summary of this book is present in the title, *Nonviolence or Nonexistence*. I grew up knowing closely the violence of my father. He was violent with me and also with my stepmother (after my mother's early death). As a boy, I thought this was the life for men. I was living a lie. But I soon learned about nonviolence from Martin Luther King and, with much more detail, from Mohandas Gandhi of India. Later, I read the works of Gene Sharp of Harvard, who emphasized strongly that we must abandon violence. Early in my adult years, I became a devotee of nonviolence, especially after I learned that nuclear weapons were manufactured at the Rocky Flats Plant near Boulder, Colorado, where I lived. Achieving closure of Rocky Flats was a major accomplishment for devotees of nonviolence. In words I used as a visiting professor at the University of Denver, "I am a body in the body of the world." Drawing on a lifetime's experience of nonviolent thought and activism, this book emphasizes that to survive, we must end our devotion to violence.

Das Buch seziert an diesem Spezialthema, wie konspiratives Denken aufgebaut ist, und stellt dem ein methodisch kontrolliertes Arbeiten mit dem Quellmaterial entgegen. Es erörtert hierbei im Detail Geschehnisse in der militärischen und zivilen Flugabwehr im Krisenereignis 9/11. Warum wurde trotz einer Attackendauer von rund zwei Stunden nicht ein einziges der 9/11 entführten Flugzeuge durch das Militär abgefangen? Das Buch bietet eine eigene organisationstheoretische Erklärung für diesen Sachstand an und weist alternative Deutungen im selben Atemzug zurück. Vertreter alternativer Deutungen von 9/11, die mit Büchern in die Bestsellerlisten wanderten und Filme mit Millionen Views auf Youtube produzierten, gehen von einem gezielten Sabotageakt aus, der durch Elemente innerhalb des Militärs gesteuert wurde. Szenarien sind vielfältig: Es wurde durch gleichzeitige Kriegsspiele eine gezielte Verwirrung geschaffen. Auf den Radarschirmen wurden künstliche Signale simuliert. Reaktionsketten wurden gezielt verschleppt. In die Türme des World Trade Centers wurden ferngelenkte Flugzeuge gelenkt. Im Nachgang der Anschläge wurden Gegenbeweise gezielt unterdrückt und gefälschte Beweise in Umlauf gebracht. Die Anwürfe sind überprüfbar, da durch Archivierungsvorgänge und Freigabeklageverfahren eine große Menge an Primärdaten zur Flugabwehr der Forschung zugänglich ist. Diese Primärdaten umfassen u.a. militärischen Funkverkehr, zivilen Funkverkehr, Black-Box-Daten und Radardaten. Diesen Datenbestand gleicht das Buch mit den verschiedenen Szenarien ab.
